Summary of discussion item: Consider Action to Expel A Student From School

Motion made by: Jeff Krumwiede

Motion to: I move that the Board expel Student #2023-11 from Carrollton Community Unit School District #1 for the period September 5, 2023, through and including September 5, 2025, based on the evidence presented at the expulsion hearing and the Board’s determination that the student engaged in egregious conduct and that the student’s continued presence at school poses a threat to the safety of other students and staff and substantially disrupts the operation of the school. The Board further finds that given the severity of the student’s misconduct, there are no other appropriate disciplinary interventions available and that the presence of the student at school will foster a culture that the student’s behavior at school is acceptable or tolerated. The Board further finds that it has been determined that the student’s misconduct was not a manifestation of the student’s disability. The student will continue to receive special education services during the period of expulsion, with a placement to be determined by the student’s IEP team. The student, during the period of his expulsion, is prohibited from attending or being

present at any Carrollton Community Unit School District #1 school related events, whether the event is on or off school property and shall not enter upon any Carrollton Community Unit School District #1 property at any time, except with the prior written permission of the Superintendent.
