Summary of discussion item: Consider Action to Expel A Student From School

Motion made by: Tammy Weber

Motion to: I move that the Board expel Student #2024-12 from Carrollton Community Unit School District #1 for the period February 13, 2024, through and including the completion of the 2024-2025 school year, based on the evidence presented at the expulsion hearing and the Board's determination that the student engaged in egregious conduct and that the student's continued presence at school poses a threat to the safety of other students and staff and substantially disrupts the operation of the school. The Board further finds that given the severity of the student's misconduct, there are no other appropriate disciplinary interventions available and that the presence of the student at school will foster a culture that the student's behavior at school is acceptable or tolerated. The Board further finds that it has been

determined that the student's misconduct was not a manifestation of the student's disability. The student will continue to receive special education services during the period of expulsion, with a placement to be determined by the student's IEP team. The student, during the period of his expulsion, is prohibited from attending or being present at any Carrollton Community Unit School District #1 school related events, whether the event is on or off school property and shall not enter upon any Carrollton Community Unit School District #1 property at any time, except with the prior written permission of the Superintendent. The expulsion shall be held in abeyance and the student be offered an opportunity to be administratively transferred to an alternative school as determined by the District's Administration, pursuant to Article 13A of the Illinois School Code. The expulsion being held in abeyance is contingent upon the student's full participation in the alternative school program, including regularly attending school; complying with attendance policies, school rules, and any referrals for services or counseling made by the alternative school; and successfully completing the alternative school's curriculum. Should Student #2024-12 fail to fully participate in the alternative school program and the alternative school refers the student back to the District, Student #2024-12 shall be immediately expelled from Carrollton Community Unit School District #1G44@88 for the remainder of the District Administration's recommended expulsion duration through the end of the 2024-2025 school year. The Student shall be afforded an opportunity to apply to the Board of Education for early reenrollment if and when the student and his family feel that circumstances so warrant.
